Have read and fully understand the Stoxkarts Racing Rule Book and I agree to abide by it. In addition I agree to abide by the conditions set out below.

1) I am over 16 but not over 70 years of age (If you are over 16 but under 18 you will need to complete a parental consent form SX/4 and include it with this contract) If you are over 64 but under 70 you will need to provide a Full Drivers Licence and medical certificate.

2) I am fully aware that the sport of Stoxkart Racing is dangerous and agree that i shall take part in the sport of Stoxkart Racing entirely at my own risk.

3) Not to take part, as a person or allow my Stoxkart to be used for any other type of racing, advertising or promotion within the dates of this agreement, other than with Stoxkarts Ltd. prior written permission.

4) I agree to abide by the rules laid down by Stoxkarts Ltd. and it's governing body the (Oval Racing Council International (ORCi)

5) I give Stoxkarts Ltd. the right to use my name, racing number and any photographs or video footage of me or my Stoxkart for the purpose of advertising or publicity.

6) Not to cause, or be part of or involved in any way with any action that would or could disrupt a race meeting. I also understand that I am responsible for the actions of my pit crew and family members, and understand that if their behaviour in any way disrupts a race meeting my license may be suspended or cancelled.

7) This contract supersedes any previous agreement between Stoxkarts Ltd. and myself.

8) English law shall apply to this contract and both I and Stoxkarts Ltd. agree to submit to the jurisdiction of the English Courts

9) Incomplete contracts will be returned.

10) I further agree to save harmless and keep indemnified Stoxkarts Limited, and the respective directors, officials, members, landowners, promoters, servants, representatives and agents and/or drivers and mechanics from all actions, claims, costs, expenses and demands in respect of loss, death or injury to myself, howsoever caused, notwithstanding that the same may have contributed to, or occasioned by, the negligence of the several persons or bodies otherwise than in connection with the business or activities Stoxkarts Limited, and further to keep indemnified the said parties in respect of death, injury or loss sustained by any third party as a result of the member's negligence and/or breach of contract, save in so far as in either event the said liability is covered by a policy of insurance.

11) It is my responsibility to ensure that my safety equipment is up to standard and to make sure that the Kart I intend to race conforms to the Rules and Regulations, irrespective of whether I am the owner or otherwise and I agree to drive the kart according to those Rules and Regulations.
