Stoxkarts – New Driver Welcome & Covering Letter (2026)

Welcome to Stoxkarts

We really hope you enjoy your time racing a Stoxkart and that it is everything you hope it will be. This pack is designed to help you understand what to expect on a race day and what is required before you go on track.

Your Pack

This letter accompanies either:

SXP-21 – Hire Driver Pack (Age 16+) or SXP-22 – Junior Driver Pack (Under 16)

Please read all documents in your pack carefully. They form part of the conditions under which you are permitted to race.

Junior Drivers – Competence & Licensing

All Junior drivers must hold a full Junior Licence. As part of being allowed to race, Juniors must either: Successfully complete a Stoxkarts competence test (theory and kart control), or Hold a current ORCi licence in another recognised formula.

A parent or legal guardian must read and understand the Stoxkarts Rules and Regulations before applying for a Junior Licence and is responsible for the junior driver at all times while at the circuit.

Signing In

On race day you must: Sign in with Stoxkarts Ltd at the Stoxkarts Trailer and get your day licence or Junior Licence for signing in with the track and scrutineering. You then need to take your day licence and sign in with the track promoter. Drivers under 18 must have a parent or guardian present to sign in on their behalf. After signing in you will be introduced to the team looking after you and shown your kart. If you have any questions, please ask – everyone is there to help.

At the Track

There is a walking-pace speed limit in the pits. No passengers are allowed on or in karts in the pits. You must attend the driver briefing before racing starts. You will be called to the track for your races and given grid instructions over the raceceiver. Do not speed around the circuit until instructed.

Flags and Radio

All flag signals are explained on the SX-7 Flags form. You must know and understand them. Raceceivers are in use – if you cannot hear, you must retire to the infield.

During incidents, remain in your kart with seatbelts fastened and arms inside until instructed by a marshal.

End of Races

A race does not end at the chequered flag. Continue racing until you see a red flag and are instructed that the track is safe. After racing, follow radio instructions back to the pits.

We wish you a safe, enjoyable and exciting time racing with Stoxkarts.



SXP-21 – Stoxkarts Hire Driver Pack Index (2026)

Purpose

This document defines the official Hire Driver Pack for Stoxkarts Ltd. It applies to all drivers aged 16 or over using an SX-3 Day Licence. Drivers under 16 must hold a full Junior Licence (SX-2) and are not eligible to use an SX-3 Day Licence.

Driver Requirements

All hire drivers must complete and sign SX-3 and SX-7, SX-4 (If Under 18) and must read and agree to SXP-20 and SXP-6 before being permitted to race.

Safety Equipment

You are welcome to wear your own safety equipment as long as it conforms to ORC rules. A Helmet, neck brace, balaclava, gloves and raceciver are supplied by the hire team. You must supply your own footwear which must cover the ankle bone.

Version Control

This pack applies to the 2026 season and supersedes all previous Hire Driver Packs.

SAFETY AND RACING RULES

1. PPE must comply with Stoxkarts Ltd rules.
2. Shatterproof goggles or visors must be worn at all times.
3. Flag signals must be obeyed as per the S/X 7 Flags Form.
4. Remain in the kart on track/infield with belts fastened and PPE on unless the kart is on fire. Arms must remain in the kart at ALL times.
5. Obey all official instructions – failure results in penalty or disqualification.
6. Mechanics may only enter the track when invited for parade laps.
7. No passengers are allowed on the Kart.

CONTACT RULES

The use of contact is an integral part of Stoxkarts racing; Karts may use the front bumper to hit the rear bumper of the Kart in front to gain a legitimate position or spin a kart in the corner. Spinning down the straights is strictly forbidden, as are follow-ins or aggressive driving, driving recklessly or in a manner deemed to be a danger to others. Without limitation it is not permitted to: Make deliberate contact with another kart whilst not travelling in a racing direction. Make deliberate contact in such a way that the contacting kart follows the contacted kart into the safety barrier. Deliberately baulk a faster kart not on the same lap. Deliberately spin a Kart on the straights. Hit a kart into a stationary kart.

STOXKARTS 2025 DAY LICENCE CONTRACT & CONDITIONS

Day Licences are normally not issued to competitors over 65 years of age unless they hold a current licence in another ORCi formula or have competed within the previous 12 months without medical restriction. This requirement is applied for safety reasons. Any driver under 18 years of age must have completed a SX/4 Parent Consent Form.

Bring this Day Licence application to the stadium and hand it in when signing in to race.

First-time Stoxkarts Drivers must bring a Flags form (SX/7) - Valid Photo ID. Failure to supply these could result in the refusal to race.

STOKKARTS

STOKKARTS FLAGS & SAFETY GUIDE SX/7 – 2026

At Stokkarts, our team is committed to ensuring that your racing experience is both enjoyable and safe. The safety of every driver, official, helper, and spectator is our top priority.

Please carefully read the following safety information and flag signals before taking part in any race meeting.

RACE REQUIREMENTS

Drivers must wear the following at all times while on track:

- ✓ An approved helmet ✓ Racing suit ✓ Neck brace ✓ Gloves

RACE OFFICIALS

All meetings are governed by the Race Director/Steward of the Meeting, assisted by the Clerk of the Course, Pit Marshal, Track Marshals, and Stokkarts Ltd. officials.

All instructions from officials — whether via Raceceiver, verbal commands, hand signals, lights, or flags — must be

FLAGS

followed immediately and without question.

- Green Flag / Light: Track is clear – race at full speed.
- Static Yellow Flag / Light: Caution – stationary kart(s) ahead.
- Waved Yellow Flag / Flashing Light: Stop safely – no overtaking – await instructions.
- Red Flag / Light: STOP IMMEDIATELY – Serious incident. Remain belted in.
- ✗ White Flag with Red Cross: Technical disqualification – retire to the infield.
- White Flag with Blue Spot: Oil or debris on track – proceed with caution.
- Black Flag: Disqualified – retire from the race immediately.
- Union Jack Flag: Race has reached the halfway point.
- Black/White Chequered Flag: Race winner finished – keep racing for placings.

■ ● Chequered Flag with Red Light: Race over – slow down and exit safely.

When waved yellows or flashing lights are shown:

Reduce speed to a stop in single file. Do not overtake. Stay in your position. Do not re-pass if overtaken – leave it to

the Steward. Do not wave other karts past. Retire to the infield if you cannot hold pace. Remain strapped in until told otherwise by an official. Do not remove belts or aerofoils unless instructed. If injured, count to ten, then signal with a 'thumbs down'. If unconscious during a meeting, the senior medic will decide if you may continue.

SXP-20 HIRE DRIVER & DAY LICENCE HOLDER – ABBREVIATED RULES 2026

Please sign and bring with you to the meeting you intend to race at.
These rules form part of the SX/3 Day Licence and must be read and signed before racing.

SIGNING IN

All drivers must sign in with Stoxkarts Ltd and with the track promoter. Signing in closes 30 minutes before race start. Drivers not signed in will not be permitted to race. Attendance at the drivers briefing is mandatory. Drivers under 18 must attend with their parent or guardian

CONDUCT

Stoxkarts Ltd. reserves the right to refuse or withdraw participation where reasonably necessary for safety, safeguarding, governance or the good order of the sport, in accordance with the Equality Act 2010. Violence, verbal abuse, harassment, bullying, sexual or racial abuse of officials, competitors or Stoxkarts Ltd., including related social media activity, will not be tolerated. Drivers are responsible for the behaviour of their team. Juniors must be supervised at all times by their parent/guardian.

SAFETY

Arms must remain inside the kart at all times. Aerofoils must not be raised unless instructed by an official. Footwear must cover the ankle bone. Any medication affecting safe racing must be declared on the SX/3 Day Licence

RACING & CONTACT

Front bumper to rear bumper contact in corners is permitted. Spinning on the straights, follow-ins, reckless driving, fencing, baulking or hitting stationary karts is forbidden.

RACECIEVERS

Raceceivers are mandatory. If radio communications cannot be heard the driver must retire to the infield immediately.

DISCIPLINARY PENALTIES

Penalties may include exclusion, meeting bans, multi-meeting bans or licence withdrawal and may be reported to ORCi.

ORCI STANDARD INFRINGEMENTS

Verbal abuse – 3 month ban
Threatening behaviour – 6 month ban
Physical abuse – 12 month ban (second offence 3 years)
Any offence involving an official – penalty doubled

STOXKARTS SPECIFIC PENALTIES

Repeat offences double penalties.
Deliberate contact not racing direction – 12 month ban
Fencing another kart – minimum 4 meeting ban
Hitting a stationary kart – minimum 4 meeting ban
Contact under red flags – minimum 4 meeting ban
Contact on infield – minimum 3 month ban
Contact after chequered flag before release – minimum 2 meeting ban
Verbal abuse – minimum 3 month ban
Physical violence – minimum 12 month ban
Arm out of kart when live – exclusion from results

SXP/6 – DATA PROTECTION & PRIVACY POLICY

STOXKARTS DATA PROTECTION & PRIVACY POLICY

Data Controller

Stoxkarts Ltd. is the Data Controller for the purposes of the UK General Data Protection Regulation (UK GDPR) and the Data Protection Act 2018.

1. PURPOSE

Stoxkarts Ltd. is committed to protecting your personal data. This policy explains how we collect, store, use, and share data in line with the UK General Data Protection Regulation (UK GDPR) and the Data Protection Act 2018.

2. WHAT INFORMATION WE COLLECT

We may collect the following information:

- Full name, date of birth, contact details
- Licence applications and medical declarations
- Parental/guardian contact (for Junior drivers)
- Emergency contact and medical declaration info
- Race results and disciplinary records
- Images, videos, or audio for media and promotion.

3. WHY WE COLLECT IT

We process personal data to:

- Administer licences and event entries
- Comply with ORCi and insurance requirements
- Provide safe medical and safeguarding support
- Communicate with drivers and guardians
- Promote events and race achievements (with consent)

4. LEGAL BASIS FOR PROCESSING

We process personal data under the lawful bases of:

- Consent (e.g. use of photos for social media)
- Contract (e.g. licence and entry forms)
- Legal obligation (e.g. safeguarding duties)
- Legitimate interest (e.g. race administration and safety)
- Where we process medical or safeguarding data, this is treated as special category data and processed only where necessary for safety, safeguarding, or legal obligations, and with appropriate safeguards in place.

5. DATA SHARING

We only share personal data when necessary, for example:

- With ORCi for regulatory/licensing purposes
- With medics in the event of an incident
- With safeguarding professionals where a concern is raised
- With insurers in case of an accident or claim
- With media teams, only where permission is granted

6. HOW WE STORE YOUR DATA

- Paper forms are stored securely and shredded when no longer required
- Digital records are stored on password-protected systems
- Only authorised personnel (e.g. DSOs, officials) have access
- Medical and safeguarding data is stored separately and confidentially
- Personal data is retained only for as long as necessary to meet licensing, regulatory, insurance, and safeguarding requirements, after which it is securely destroyed.

7. PARENTAL CONSENT FOR JUNIORS

For all Junior drivers (under 18), we require:

- Written parental consent for data processing
 - Explicit permission for media use
 - Parent/guardian contact for emergencies
- = We take additional care when processing children's data and limit access to authorised personnel only

8. YOUR RIGHTS

You have the right to:

- Request access to your personal data
- Ask us to correct inaccurate information
- Request deletion of data (where applicable)
- Withdraw consent at any time
- Raise concerns with the Information Commissioner's Office (ICO)
- Consent for media use may be withdrawn at any time by contacting Stoxkarts Ltd. in writing. Withdrawal will not affect lawful processing prior to withdrawal.

PARENT / GUARDIAN AGREEMENT SX/4 – 2026

This agreement applies to all competitors under the age of 18 where parental or guardian consent is required.

I have read, understood, and accept the following terms and conditions:

1. I acknowledge that my child wishes to participate in racing events organised by Stoxkarts Ltd. and I am familiar with the nature of Stoxkarts racing and the risks involved.
2. I confirm I have been given the opportunity to inspect the track and its facilities prior to giving consent, and I am satisfied that it is safe and appropriate for my child to participate.
3. I confirm that my child is medically and physically fit to compete safely in Stoxkarts racing. To the best of my knowledge, they do not suffer from any condition (physical or mental) that may affect their ability to race safely.
4. I accept full and continuing responsibility for ensuring my child complies with all Stoxkarts Ltd. rules and regulations. I will ensure that both my child and I have read and understood the current Stoxkarts Rulebook.
5. I understand that attendance at the Driver Briefing is mandatory for all Drivers and I agree to attend the briefing with my child and that I am responsible for the supervision and conduct of my child at all times during race meetings
6. I understand and accept that motorsport is potentially dangerous. In consideration of Stoxkarts Ltd. allowing my child to compete, I agree to indemnify and hold harmless: Stoxkarts Ltd., all event officials and marshals, the landowners, promoters, their agents, and other competitors, from any claims, damages, or liabilities arising from my child's participation. Nothing in this agreement excludes or limits liability for death or personal injury caused by negligence where such liability cannot lawfully be excluded.
7. I declare that the kart used by my child is suitable, safe, and race-worthy, and complies with all specifications set out in the Stoxkarts Ltd. Rulebook.
8. I understand that the consumption of alcohol or any intoxicating substance by myself is strictly prohibited while signed on at a race meeting. I acknowledge that any breach of this rule may result in immediate suspension of the driver's licence.

DATA PROTECTION

I consent to Stoxkarts Ltd. processing my personal data and my child's personal data in accordance with the UK General Data Protection Regulation (UK GDPR) and the Data Protection Act 2018 for the purposes of licensing, safeguarding, safety management, administration, and communication.
